IMPACTS OF THE GLOBAL ECONOMY *FOREIGN EXPORT-DEPENDENT INDUSTRIES*

Foreign Export-Dependent Industries in Missouri

The demands of people around the world greatly contribute to job creation in Missouri. Export industries in Missouri account for over 94,800 jobs (3.1%) of total employment in the state. Average earnings per worker are 27% higher in export dependent jobs than in non-export dependent jobs. These jobs contribute over \$4.8 Billion in labor income (3.9% of total labor income earned).

Export-Dependent Jobs

The five industries listed in this table create the greatest number of jobs dependent on exports in Missouri. However these industries are not completely dependent on foreign exports since more than 50 percent of their products are sold within the United States.

Industry Exports (50-75 Percent)

The following industries are some of the most export dependent industries in Missouri. Although they may not have the highest number of export dependent jobs, these industries would be highly impacted by a change in global demand for their product since they export 50-75 percent of what they produce.

Industry Exports (75+ Percent)

The industries listed below export more than 75 percent of what they produce. They are highly dependent on the export economy and need to be keenly aware of their export market.

Notes

Export industries were identified by the percentage of commodities shipped outside the U.S. by local producers (Foreign Exports / Total Commodity Supply).

Foreign Exports is defined as the value of all commodities produced by local industries and institutions that are shipped outside the U.S.

Total Commodity Supply is defined as the value of all commodities produced by local industries and institutions.

Employment includes wage-employment and self-employment for both full and part time jobs, and is reported as annual full-time-equivalents.

Earnings is defined as the sum of all labor income in the area. It includes employee compensation (wages, salaries and benefits) and proprietor's income (self-employment income).

Data is reported in 2006 constant dollars and is taken from IMPLAN (Minnesota IMPLAN Group, Inc.).
